1243. Ongoing Matters

- Congestion / Antisocial behaviour from visitors. We are to request that the double yellow lines from The Old Dog to the Dovedale Car Park are repainted as the paint is crumbling away.
- Closure of public toilets Derbyshire Dales District Council are still working on the rights of way across the land with the transfer of the access land to the National Trust scheduled for 31st March 2024. There is also a consultation about the provision of public toilets within Derbyshire Dales and we are to highlight the need for the toilets to be reopened.
- Telephone Box refurbishment now operating as a fudge and treats shop by Kay Thornley. She will pay £10 per month to the Parish Council after 3 months rent free.
- Village website updated as required
- Grounds Maintenance Nothing to report. Cyril to quote for next year.
- Notice Board Replacement notice board on the village hall required.
- Footpaths Whilst the path at the rear of the church was maintained, the footpath leading to Mapleton up to the River Dove needs clearing of obstructions.
- Land around the flagpole. It is confirmed that the owners of Thorpe Green own the flagpole land. However it is designated as "Village Green" which has the

right to use the land for "lawful sports and pastimes". Therefore we can continue to use the site and we continue to maintain it.

- Car Park Charging by Peak Park. Charging for the Narlows Lane and Thorpe Station Car Parks has commenced. We will monitor to see if cars are parked in the village to avoid the charge.
- Thorpe Village Hall The Village Hall Committee thanked the Parish Council for the donation of £1850 towards the refurbishment / running costs. A contingency of £1000 is being kept by the Parish Council as a new defibrillator will be needed in 2025.
